## MINUTES OF THE COMMITTEE OF TRANSPORT SECRETARIES /COMMISSIONERS (CoTS) MEETING HELD ON 17.03.2022 AT 11:30 AM THROUGH VIDEO CONFERENCING IN THE OFFICE OF NCR PLANNING BOARD, NEW DELHI.

1. List of participants is at *Annexure-I*. Discussions were held as follows:

AGENDA ITEM: Status of Notification of CRCTA & Request received via Email dated 15.03.2022 from Transport Department, Delhi.

- 2. Welcoming the participants Chairperson mentioned that the key purpose of the meeting was to get an update on the progress made by NCR States of Delhi and Uttar Pradesh regarding the necessary notifications required to be issued to expedite implementation of the 'Combined Reciprocal Common Transport Agreement' (CRCTA). The committee was again apprised that subsequent to the 'Combined Reciprocal Common Transport Agreement (CRCTA)' being agreed and signed amongst the Government of Haryana, NCT-Delhi, Rajasthan and Uttar Pradesh, and its information sharing in the 40<sup>th</sup> Board Meeting of the Board held on 31.08.2021, NCR participating States were to complete necessary action required u/s (5) and (6) of the Motor Vehicle Act 1988 within their States. It was also noted that the signed agreement was issued same day on 31.08.2021. However all further orders conveying extensions of existing Contract/Stage Carriage RCTAs, also conveyed that status quo be maintained till such extended dates.
- 3. The participants were informed about the status as under:

- 4. Chairperson appreciated the efforts made by Uttar Pradesh subsequent to last meeting for issuing the final Notification of CRCTA (Hindi & English) under section 88(6) of Motor Vehicle Act 1988 on 14.03.2022 and advised the participants from Delhi to do the needful at the earliest.
- 5. The request of Transport Depart, Delhi vide its email dated 15.03.2022 was shared with other states. As informed, Delhi was in the process of obtaining final approvals for the RCTA from Hon'ble LG Delhi, and expected to receive the same within a week. Commissioner Transport, Delhi, updated that the CRCTA has been approved by Hon'ble Transport Minister of Delhi and expected to be approved by Hon'ble Lieutenant Governor of Delhi as well as, without any changes, and efforts will be made to notify the same by evening today. It was decided that notification of CRCTA by Delhi shall be awaited by evening and incase it does not happen by evening, another order be issued to extend the terms and conditions of both existing RCTA, which shall be continued to be abided, and status quo maintained, by States till the final issue of CRCTA by NCRPB as per its provisions, or till 27.03.2022, whichever is earlier. Chairperson suggested that Delhi should make necessary arrangements for early publishing. It was also decided that if NCT Delhi notifies the CRCTA by evening, then the Combined RCTA shall be finally issued by NCRPB to make it effective as per its provisions.
- 6. Accordingly following was decided after unanimous agreement with regards to extension of existing RCTA:

The terms and conditions of both the existing Reciprocal Common Transport Agreements shall be continued to be abided and status quo be maintained by NCR participating States up to 27.03.2022 for Contract Carriage and Stage Carriage or till further orders, whichever is earlier.
