MINUTES OF THE COMMITTEE OF TRANSPORT SECRETARIES/ COMMISSIONERS (COTS) MEETING HELD UNDER THE CHAIRPERSONSHIP OF MEMBER SECRETARY, NCR PLANNING BOARD ON 05.11.2024 AT 11.30AM IN TAMARIND, INDIA HABITAT CENTRE, NEW DELHI.

List of participants is at **Annexure-I**.

Member Secretary, NCRPB and Chairperson, CoTS welcomed the participants, Director (A&F), NCRPB briefed about the key agenda point through a short presentation. The copy of presentation is at **Annexure-II**. Brief of discussions and decisions made thereof, are as presented below:

AGENDA ITEM NO.1: Confirmation of Minutes of last CoTS meeting (29.02.2024)

1. The Committee noted that no comments have been received on the Minutes of its meeting held on 29.02.2024. Accordingly, the Minutes of the said CoTS meeting were confirmed.

AGENDA ITEM NO. 2: Action Taken on Decisions of last CoTS Meeting held on 29.02.2024.

2. Committee noted the status and was further apprised that the aspects were being discussed in detail as separate agenda items.

AGENDA ITEM NO.3: Regional Connectivity Issues

3. Issues related to Interstate connectivity road/linkages in NCR.

Road links related to Interstate connectivity road/linkages in NCR were taken up for discussion as below:

- I. UER-I, Delhi to Khekra City till NH-57 and UER-II, Delhi to Tronica City till NH-57 in Uttar Pradesh
- 3.1 Representative from NHAI updated that the work UER-II has been completed. Regarding UER-I and III, it was suggested that earlier decisions on the matter be looked into by NCR cell, Delhi and updates be taken from concerned agencies. An assessment of actual site realities may also be done by NCR Cell Delhi.

Decision:

i) Committee requested NHAI to share the updated status with NCRPB in 2 days.

(Action: NHAI)

ii) NCR P&MC, Delhi may refer earlier decisions on the matter and follow up after taking updates from concerned agencies.

(Action: NCR PMC Delhi)

II. Road from Ring Road (Inder Lok Metro Station) & existing Yamuna Canal Link Road up to Haryana Border

- 3.2 NCR Cell Haryana was requested to take up the matter at the highest level as matter was already taken up at the Chief Secretary level, for resolution.
 - **Decision:**
 - i) The matter may be brought to kind notice of Chief Secretary, Haryana, again to resolve the matter.

(Action: NCRPMC Haryana and PWD (B&R), Haryana)

- III. Upgrading Gwal Pahari Mandi Gadaipur- Jaunpur road up to Andheria Mor in Delhi
- 3.3 Director Planning NCR Cell Delhi informed that tentative cost estimates of the 8.8 Km stretch have been received as Rs 106 Crore for land and Rs 249 Crore for construction. File is with PWD. The representative of NCRPMC Delhi was requested to provide the latest status in writing and expedite the matter.

Decision:

NCRPMC Delhi to provide the latest status in writing within a weeks' time and expedite the matter.

(Action: NCRPMC Delhi & PWD-Delhi)

- IV. Kalindi By-pass Road from Ashram Chowk, Delhi to Faridabad By-pass:
- 3.4 Representative from NHAI apprised that GAD is under revision to avoid pier in Canal and due to this the project cost is likely to increase from Rs. 82 Cr. to Rs. 124 Cr. The contractor has requested for extension of time up to September 2025.

Decision:

Committee noted the status and requested NHAI to expedite.

(Action: NHAI)

- V. Elevated road along Shahdara drain-alignment form Chilla Regulator (near Mayur Vihar), Sector-14A to MP-3 road (Mahamaya Flyover) in Noida.
- 3.5 Committee noted that all issues has been resolved, funding approved and LoA issued. Copy of the same to be shared with NCRPB.

Decision:

Committee noted the status and requested to share the copy of LoA.

(Action: NCRPMC-UP/NOIDA)

- VI. 75 m wide road link connecting Gurgaon area with Najafgarh road
- 3.6 Director Planning NCR Cell Delhi informed that Land Acquisition cost is to be received from DM North-West Delhi. All concerned were requested to provide the latest status in writing and expedite the matter.

Decision:

All concerned to provide latest status in writing within a weeks' time and expedite the matter.

(Action: GMDA and PWD, Delhi; NCRPMC Delhi & Haryana)

VII. Bridge connecting Sector 168 & 167-A, Noida with Lalpur Village, Faridabad

3.7 Committee noted that DPR is being prepared by Haryana, PWD (B&R). The consultant has proposed 03 alignments options which are to be put up for approval of the Competent Authority. Once the alignment is approved the DPR will be finalized and project cost sharing will be done by Govt. of Haryana and U.P.

Decision:

Committee noted the status and requested all concerned to share the latest status with NCRPB within a week's time.

(Action: PWD(B&R) & NCRPMC Haryana & UP, FMDA and NOIDA)

- 4. AGENDA ITEM NO.4: Trauma care Network in NCR
- 4.1 The committee noted that subsequent to the decision of last CoTS dated 29.02.2024, NCRPMCs have submitted their respective proposals for Trauma Care network in NCR which has been further refined based on the project proposals submitted by the finance departments of NCR states of Haryana, Rajasthan and U.P. for special assistance scheme of 2024-25 of DoE and forwarded for consideration of DoE by NCRPB. It was further apprised that to have specific deliberation in the matter including air ambulance, a separate meeting is scheduled on 06.11.2024 wherein different Ministries of GoI have also been invited.
- 5. AGENDA ITEM NO. 5: Optimization of EMUs/MEMU Services in NCR
- 5.1 Committee was briefed about the decision of last CoTS meeting and the work done by NCRPB through inhouse exercise.
- 5.2 Chairperson directed that a meeting be convened at the level of Chief Regional Planner, NCRPB to discuss the matter with NCRTC.

Decision:

A meeting be convened by Chief Regional Planner, NCRPB to discuss the matter with NCRTC within 15 days.

(Action: NCRPB & NCRTC)

- 6. AGENDA ITEM NO.6: Status of Electric Vehicle Charging Stations in NCR
- 6.1 Committee noted that subsequent to EVCS infrastructure discussion and review in last CoTS meetings, the OMCs have taken steps for installation of EV charging station (EVCS) in NCR. It was apprised by the representative of BPCL informed that out of total 315 agreed ROs, EVCS have been commissioned at 19 sites, and at 246 ROs chargers have been delivered and installed but no power connection has been provided so far. In case of Haryana out of total 121 applications demand note has been received for 36 and pending for 85. In U.P. sub region, out of total 82 applications demand note is received for 43 sites whereas pending for 39 sites. In Rajasthan sub region, demand note is yet to be received for all 6 applications. It was further apprised by the OMCs that all delivered instruments are of 60 KW new version with dual gun system.
- 6.2 Further OMCs raised their concern regarding area requirements under Delhi DERC code (>600 sq.mt.) and installation of transformers for power supply to EVCS. The representative of power distribution companies apprised that they have given their comments in the matter and have requested DERC for relaxation. Chairperson directed all OMCs and DISCOMs to share details of all such cases along with the copy of letters/comments shared with DERC with NCRPB in 2 days' time.

- Committee noted that NHAI has decided to take up both the interchange i.e. at Noida International University and on Palwal-Aligarh Road near Jattari, and written update will be

AGENDA ITEM NO.8: Status of Implementation of Bypasses in NCR. 8.

Representative of Haryana informed that there are 11 towns with Development Plans in Haryana sub-region out of which only 02 plans have proposals for Bypasses. He added that the status in this regard was shared with NCRPB on 28.02.2024. Representative of U.P. informed that all Master Plan (11 nos.) of U.P. sub-region has proposal for Bypasses and are under different stages of implementation. He further stated that the status was provided to NCRPB on 12.03.2024. CTP NCR cell Rajasthan informed that sub-region Rajasthan has 2 cities for which he is in touch with DMs for getting proposals.

Chairperson directed that efforts should be made to have proposals for all towns having 1 lakh plus population as per Census 2011. It was also requested to the representative of UT/MRTS division of MoHUA that MoHUA may consider to have a mechanism/ policy for Bypasses for Decision:

- (i) NCRPMCs should make efforts to have proposals for all towns having 1 lakh plus
- (ii) NCRPB to examine status of Bypasses received from NCRPMC Haryana and U.P.
- (iii)NHAI to have a meeting with all NCRPMCs before 20th November 2024.

(Action: NCRPB & NCRPMCs Uttar Pradesh, Rajasthan and Haryana)

AGENDA ITEM NO.9: Status of Implementation of Missing Links in NCR. 9.

After discussion with the representatives of NCRPMCs, concerned departments of NCR states and NHAI regarding various section taken by them for implementation of missing links in NCR, Chairperson directed NHAI to have a meeting with all NCRPMCs before 20th November Decision:

NHAI to have a meeting with NCR States/NCRPMCs on all missing links before 20th November 2024 and status be shared with NCRPB.

- ii) The matter to be taken up in CRP, NCRPB meeting.
